

From the Treasurer:

If you find the need to purchase items for the church, please be mindful that Kokomo Zion Church, Inc. is a tax-exempt entity. A tax-exempt certificate is already on file with many vendors in Kokomo – Walmart, Staples, Menards, Lowes, Hobby Lobby, Meijer, etc. Please check with Sheila or LeAnne before you purchase and we will make sure that you have the proper documentation to present at checkout to allow tax-free purchasing for the church. If a purchase is needed from a vendor that we don't already have tax-exempt status, the process is simple, but does required 24 hours to obtain the certificate. Again, contact Sheila BEFORE purchasing, and she will take care of the process. Every dollar saved in sales tax is a dollar that can be utilized for ministry. Purchases for which reimbursement is requested should be submitted to the Treasurer within 5 days of purchase and include the original receipt, including any rebate form that may be attached. Please also be sure to include your name, and the budget area from which the expenditure should be debited

Staples Rebates: A great way to use your junk to stretch the church budget is to recycle! Staples has a recycling program that awards "points" that can then be converted to cash toward purchases. A full list of items can be found at: https://www.staples.com/stores/recycling. As you begin 2025 and start cleaning closets, you'll likely find some of these items! You may bring them to the Treasurer's office and leave on the desk - Sheila will take them into Staples for you and they will credit the church's account. Or, you may take to Staples and give them the church's phone number to credit our account (765-628-3605). Common items include batteries, cables, computer speakers, coffee brewers, earbuds, calculators, toner & ink cartridges, crayons & colored pencils, empty glue sticks & bottles, pens, markers & highlighters
